FORD OPENS INTERNET WINDOW ON PEOPLE, PRODUCTS DRIVING ITS 'WAY FORWARD' PLAN

"Bold Moves: The Future of Ford" is an online documentary series allowing the world to witness the inner workings of the automaker as it rebuilds its business in North America.

The series is part of the Ford brand's Bold Moves communications platform that was announced on May 2, which is designed to showcase bold products, bold leadership and Ford customers making bold moves in their lives.

The first episode, "Change or Die," is a probing look at the state of the auto industry and Ford's business in North America told from the point of view of industry experts, journalists, consumers and people who work for Ford at all levels of the company.

Future episodes will focus on the people and products driving Ford's comeback.

Dearborn, Mich., June 27, 2006 – What would it have been like to be a "fly on the wall" when Henry Ford conceived the Model T or the legendary Rouge facility? Those moments in time are left to the imagination of historians. But,

beginning today, Ford is pulling back the curtain and allowing the public to witness what happens behind the scenes at the automaker in an online documentary series called, "Bold Moves: The Future of Ford." The debut episode, entitled "Change or Die," can be viewed at www.fordboldmoves.com

"The documentary will present a picture of a company that is committed to revitalization through our people, products, improved quality and costs, and a laser-sharp focus on the customer," said Mark Fields, Ford's President of the Americas. "Each episode will provide evidence that it's not business as usual at the Ford Motor Company and that 'Change or Die' is not a sound bite. It's the way we're approaching our future."

The Documentary

"Bold Moves: The Future of Ford" is part of the Ford "Bold Moves" marketing communications platform that was announced on May 2. The documentary is scheduled to run throughout 2006, with weekly installments beginning June 27.

On the Bold Moves Web site, viewers will see at least one new 3-5 minute video installment each week that will take them inside places the public has never seen before, including Ford executive offices, design studios and assembly plants.

"Over time, the body of work we are creating will tell a compelling story about bold products, bold leadership and Ford's customer focus," said Mary Lou Quesnell, director, Ford Brand DNA. "We will provide both sides of the conversation and let America watch Ford's turnaround as it happens."

The first episode, "Change or Die," is a frank look at the state of the industry and Ford's business in North America told from the point of view of industry experts, journalists, consumers and people who work for Ford at all levels of the company.

In an upcoming episode, Peter Horbury, executive director of North America Design, explains his

perspective on the role of design in Ford's comeback.

In another series of episodes, cameras follow racing legend Carroll Shelby at the New York International Auto Show and Ford's Special Vehicle Team (SVT) as it rolls out the first 2007 Ford Shelby GT500, the most powerful production Mustang ever built.

In addition to the video, the Bold Moves Web site will include background information on topics covered over the course of the series, point-counterpoint editorials, biographical information on individuals and an area for public "e-conversations" around each topic.

Throughout the year, visitors will be able to view previous episodes and commentary to see where issues began and how they play out over time.

The documentary series is being produced by JWT Detroit and JWT New York, and directed by Radical Media Inc., a New York-based production company whose credits include many acclaimed documentaries, TV programming, feature films and an Academy Award for a previous documentary. Taping began in April 2006 and continues through the end of the year.

MOCKLER ON THE HUNT

Clermont, Ind. -Stephanie Mockler, driver of the No. 6 East Enterprises Beast/Clorox/Ford Racing Midget Series car, returns this weekend to O'Reilly Raceway Park in Indianapolis where she posted her best career National Midget Car Series finish with a third-place effort in May. Mockler talks about getting ready for her busy racing schedule over the next two weeks.

You finished fifth at Anderson (IND.) Speedway, a place where you won earlier in the year. It seems you run consistently well there. "Yeah, we struggled there the other night on Wednesday, in the heat race we had motor troubles. At first they were only going to give us one practice but then decided to give us two, so we were pretty set there. We had engine trouble and it ended up being something electrical. I ended up running the heat race and we won it, but then they changed everything electrical in the car to make sure it was electrical and it was internal, they weren't sure, so they changed everything electrical and we started eighth.

"I was the quick time or had the most points and I had to draw the invert and you can either draw fourth, sixth or eighth, and, of course, I drew eighth, which is the worst. It ended up being all right. The car was kind of pushing in the feature, we just couldn't get around the fourth-place guy to get up there."

In each of the next two weeks, you are running two races. Do you enjoy doing more of a back-to-back racing schedule? "Yeah, I do like that a lot. It's going to be a lot of fun this week, because we go the first [of July] at O'Reilly and then we go the fourth at Columbus [Ohio] and then we go the eighth at Toledo, so that will be a lot of fun. They are all National Series

races so it will be cool to run with those guys.

"With the schedule coming up, we tested at Toledo and that went pretty well. At the end we had some troubles and weren't able to finish the test. We are going to Columbus as well and we haven't been there before. So now at Toledo I have a little experience and then at Columbus it will just be fun to try and figure out everything in one night."

You return to O'Reilly Raceway Park at Indianapolis this weekend. You finished third there earlier in the year in your first race at the track. Are you looking forward to returning to the place where you posted your best national series finish? "Yes, definitely. I'm looking forward to it because I learned a lot of things in the race. We tested there a few times, but I learned a lot of things in the race that I would not have learned in testing and it just taught me a lot. Hopefully, I'll be able to go there and qualify well now and start up front and have a chance to win the race, because coming from 15th is tough."

Last time at the track, you seemed to run a higher line than most of the competition and were able to pass with some ease. Do you plan on using that high line again? "The line I plan on running is the one that everyone else is not. If everyone is running high, you just have to figure out a way to go around them. Everyone says I haven't been on that track that much, but everyone says that the track changes a lot night to night."

With a few testing sessions and a race under your belt at this track, do you feel prepared for this weekend? "Yeah, I do. I feel a lot more prepared. Last time it was a lot of fun to know that everyone supported me."

The MCA National Board of Directors (**BOD**) meeting was held at Johnson City, TN. with 29 MCA officers, and National & Regional Directors in attendance. The following excerpts are from that meeting.

EXECUTIVE COMMITTEE: Approved among other things MCA's Operating budget for 2006; obtaining property coverage insurance cost of \$525 per year; budgeted for purchase/rental of a 20 by 20 tent to be used at MCA Events that is not to exceed \$500 per event or \$2,000 per year. The use will be for accessories and membership sales.

TREASURERS REPORT: MCA remains solvent.

ADMINISTRATIVE COMMITTEE: Reported no claims or calls; 120 certificates for static shows with 87 used & 10 certificates for driving events with 3 used so far.

The annual officer's installation banquet for 2007 will be in Phoenix, AZ January 13TH and 14TH, 2007.

CLUB CHARTER COMMITTEE: Received a request from the Classic Mustang Long Island Region stating that the Classic Mustang LIR and the Long Island Mustang and Shelby owners club have merged into one club. Their boundary will remain the same. They have requested a name change to Mustang and Shelby Club of Long Island LTD.

An inquiry was received from the Bullitt Club about the possibility of becoming a MCA affiliate club. A list of benefits of to having MCA Registry (groups) clubs as affiliates was presented. Motion made to accept MCA Registry Clubs Affiliates (Foreign and US) into MCA with a minimum of 10 MCA members and approved by the

BOD. These were approved by the BOD.

An inquiry was received from the Bullitt Club about the possibility of becoming a MCA affiliate club. A list of benefits of to having MCA Registry (groups) clubs as affiliates was presented. Motion made to accept MCA Registry Clubs Affiliates (Foreign and US) into MCA with a minimum of 10 MCA members and approved by the BOD.

JUDGING COMMITTEE: Reported that the judging meeting will probably be at St. Louis, MO in early November. They are working on a new award called the platinum award. Mustangs Unlimited (MU) will sponsor this award for future and past recipients. Company providing the award will bill directly to MU and then UPS it to the winner. A letter will be developed for each winner of the award and sent to recipients.

MEMBERSHIP COMMITTEE:

- Proposal for direct marketing promotion called "Extend Your Hand" was presented. Motion to approve the proposal was made and approved by the BOD.
- Proposal for special military promotion was presented. Motion to approve the proposal was made and approved by the BOD.
- Proposal direct marketing promotion – deferred payment plan (trial run at Carlisle All-Ford Nationals, June 2, 3, 4, 2006) was presented. Motion to approve the proposal was made and approved by the BOD.
- Proposal special promotion – The Heritage Program-

Christmas/Holiday gift was presented. After discussion it was decided to remove the Heritage Program and proposal for monies to go to a separate account and call the promotion the Christmas/Holiday Program. A motion to approve the Christmas/Holiday proposal was made and approved by the BOD.

NOMINATIONS COMMITTEE:

- As of May 25th one bio for the BOD has been received from a new applicant.
- Bio's from current BOD members whose term expires in Dec are requested ASAP.
- Request to the Club Support Committee to send a broadcast to the Regional directors asking if they would be interested in running for National BOD positions.
- Request for suggestions on how to obtain applicants for the Board was also made.

PUBLISHING COMMITTEE:

This took a lot of time, but we did persevere. The guy with the 7 stunning cars did get several awards.

July 2006 Car Hobbyist News From the Council

We have only had a couple of high ozone days this summer. Those days were the ones in the upper 90's. I am hopeful that the DEQ and EPA realize that ozone is caused more by weather conditions than any other factor. In fact the state plans to ask the EPA to remove the Richmond and Hampton Roads areas from the smog list. I'm sure the EPA will not remove either region from the list. But there is some good news about pollution in Virginia.

The DEQ is tightening up pollution coming from power plants. The new rules are stricter than the guidelines from the EPA. Hopefully this will mean less air pollution and less attention directed toward vehicles. We do not want to begin emission testing of vehicles as is done in Northern Virginia.

The Supreme Court has taken up the case on regulating pollutants. States are fighting Bush administration officials over regulating carbon dioxide from cars and trucks. The Bush administration does not want to regulate carbon dioxide and "greenhouse" gases. Several states want the gases regulated and in reality they want something done about global warming. The court will decide whether the federal government has the power under the clean air laws to treat carbon dioxide as a harmful pollutant. The EPA plans to argue vigorously that it will not regulate carbon dioxide.

For those of you who have forgotten elementary science – animals emit carbon dioxide. We humans exhale carbon dioxide. Green plants take in carbon dioxide and use it in the process called photosynthesis. During this process water, carbon dioxide and sunshine cause plants to produce sugar and oxygen. This is a natural process and the end results are things like apples, oranges, tomatoes, etc.

The decision by the Supreme Court will be very interesting. It could determine what actions the United States takes on global warming.

At the last council meeting there was a lively discussion on what to do about the interpretation of laws that govern antique vehicles. Unfortunately there are laws written in a manner that allows them to be interpreted two or more different ways by different individuals and/or local governments. This problem has escalated for a number of reasons that we discussed at the meeting. Actions can have reactions so we have to be careful with our decisions on how to deal with such items. I am sure all of

us are looking forward to getting this resolved and having answers in the next newsletter.

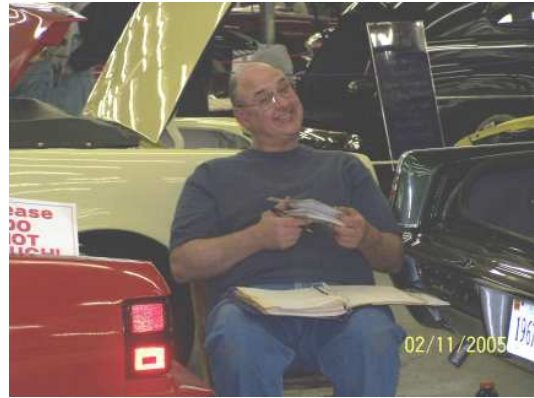

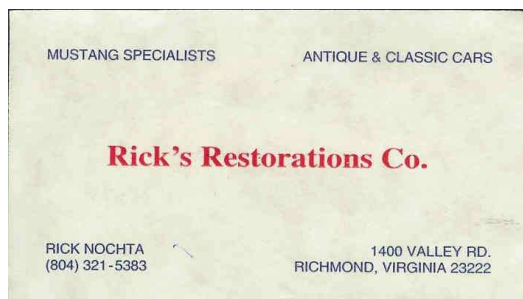
