A message from MCA Headquarters: as you are all well aware, you have to have your club updates in to MCA by March 1st of each year. There needs to be a minimum of ten MCA members and that includes your club officers which all must be MCA members. If you have the standard officers, President, Vice President, Secretary, Treasurer and Regional Director, you are half way there. The goal is not to just make ten, but to exceed it. You may have members that are not interested in anything but attending National shows and driving events. Since you must be an MCA member to attend the National Shows, that's one great thing the Associate membership allows. It also lets your club have people join your club and MCA which helps us both.

Now, some people like magazines in the hand and some like it online. For \$35 you can join, and view Mustang Times on line each month or for \$50 you can still join like it always has been and get Mustang Times delivered!

The associate member cannot vote in MCA elections, hold MCA offices (Regional or National Director and does not have access to Mustang Times), however, everyone gets a membership number and card, website access, Fords X-Plan and entry to the MCA shows.

The pawl spring prevents the door from unlatching. In certain situations where the door is able to be closed, the door may unlatch with driving, increasing the risk of injury.

OCTOBER 2016 CAR HOBBYIST NEWS FROM THE COUNCIL

I have sent a letter to my delegate to the General Assembly asking him to sponsor a bill to change the current exhaust law. The change would be to this paragraph: "The provisions of this section shall not apply to (i) any antique motor vehicle manufactured prior to 1950, provided the engine is comparable to that designed as standard factory equipment for use on that particular vehicle, and the exhaust system is in good working order, or (ii) converted electric vehicles."

The 1950 would be changed to 1975 – the year cars and light trucks were required to have catalytic converters. I will let you know if he agrees to sponsor the bill and have already gotten a letter from his aide saying that they are researching the possible bill.

Illinois has passed a law to teach new drivers how to act if stopped by law enforcement. The law sailed through the legislature and has been signed into law. I think it is a great idea to include this info when teaching people how to drive. "Being pulled over by an officer is really stressful," State Senator Julie Morrison, a co-sponsor of the bill, said. "I think it's really important, especially in this time that we're in, that kids and new drivers learn what is expected when they are stopped by an officer, how to respond correctly, to be respectful, and hopefully that will make the encounter as least problematic as possible. I'm hoping it protects both

the officer and the driver from things escalating."

You may have an old vehicle that you'd like to find out more about and the best way would be to contact previous owners of the vehicle. If you go to DMV you will be told that giving out that information is against federal law. In 1989 actress Rebecca Schaeffer was shot and killed by a man who had been stalking her for 3 years. He was able to find her by paying a detective agency to use DMV records in order to obtain her address. This led to the federal law that made it illegal to give out information that could allow someone to find your address. The federal law is at this link: www.gpo.gov/fdsys/pkg/USCODE-2011-title18/pdf/USCODE-2011-title18-part1-chap123-sec2721.pdf

Also note this section of this law: "(3) For use in the normal course of business by a legitimate business or its agents, employees, or contractors, but only— (A) to verify the accuracy of personal information submitted by the individual to the business or its agents, employees, or contractors; and (B) if such information as so submitted is not correct or is no longer correct, to obtain the correct information, but only for the purposes of preventing fraud by, pursuing legal remedies against, or recovering on a debt or security interest against, the individual."

If you – like me – have gotten those notices in the mail stating that your vehicle's warranty has expired or a notice from a car dealer asking to bring your vehicle in so they can buy it or offer it as trade for a new car – then it appears those people are violating the law. Apparently car dealers sell this information to other dealers or warranty companies and this is against the law. I called and spoke with a woman in the State Attorney General's consumer office and she said that she knew about the federal law and that I could file a complaint. Trying to sell an extended warranty or a new vehicle is

not covered in the law.

It is legal to contact you if your vehicle is being recalled or there is a safety or emissions problem with the vehicle. The law does not provide for car dealers to use this information for any other reason. I got an email from Energy Citizens, a grassroots organization that advocates for America's energy future. The email was asking for us to contact a couple of members of Congress from Virginia asking them to sign on as co-sponsors of HR 5180 - Food and Fuel Consumer Protection Act of 2016 - To alleviate the ethanol blend wall under the renewable fuel program, and for other purposes. The bill – at this writing – has 113 co-sponsors in Congress.

The bill is about the Renewable Fuel Standard (RFS) that we have discussed at council meetings. The RFS requires additional renewable fuel to be used each year. Currently the only renewable fuel added to gasoline is ethanol. This is one of the reasons why the EPA approved E-15 – to simply put more ethanol into gasoline to meet the goals of the RFS and prevent running into the so called "blend wall". The problem of course is that E-15 doesn't run very well in many engines including our antique vehicles, lawn mowers, boats, all two-stroke engines plus many more. And the conversion of corn to ethanol means less food and therefore higher food prices. There have been some questions about whether ethanol really reduces pollution. The EPA has not done a complete report on ethanol since 2011 but says it will do a review in 2017 but a complete report is not going to be done until 2024. I'm not sure why the EPA does not want to thoroughly investigate the effects of ethanol.
