MCA will not be charged utility costs or require museum members to staff the booth. This 10 month contract does not bind us to renew. After a review of new membership applications acquired at the museum, a new \$15,000.00, 12 month, contract MAY BE offered.

## **MAY 2019 Car Hobbyist News From the Council**

If you drive an antique vehicle do not drive it in Warren County or the town of Front Royal. Last month I wrote about antique car hobbyists who were ticketed for having a passenger and personal effects in an antique vehicle – both are not illegal. Apparently at least three Warren County deputies have written these tickets, the Commonwealth Attorney's office has prosecuted them and a General District judge has found the car owners guilty. The person I know who got a ticket hired an excellent attorney, was convicted in General District Court and appealed to Circuit Court. There his case was non-processed by the Commonwealth

Attorney. The Circuit Court judge questioned – correctly – why the Commonwealth Attorney would non-process a case after a conviction. This is just a mess. Apparently, there are law enforcement officials who have misinterpreted the law and written tickets for violations that do not exist. I and the man who spent several hundred dollars on an attorney have both made contacts and have so far found no one who wants to deal with this. At the April council meeting I am going to discuss what action I think should be taken. Until then I am not going to list any events in the calendar that take place in Warren County or Front Royal. And again, I suggest you not drive a vehicle registered as an antique in those areas.

Let's shift gears to the feds. Right now the EPA is rushing to complete the new rule on E15 to allow its usage during the summer months. EPA considers summer to be from June 1 to September 15 so the new rule must be in place before June 1. If it is not EPA will have to come up with some kind of Plan B. President Trump asked the EPA to expand the use of E15 last fall. This is most likely to ease the burden caused by some of his tariffs that have hurt corn farmers.

Here is the overview from SEMA: "The EPA issued a proposed regulation that would allow gas stations around the country to sell E15 (gasoline that's 15% ethanol) during the summer months (June 1 through September 15). If finalized, the EPA would overturn its long-standing prohibition on the sale of E15 during high-ozone season by allowing the fuel to use the 1 pound per square inch (psi) Reid Vapor Pressure (RVP) waiver, which currently allows E10 sales during the summer months. The EPA's effort to allow year-round E15 sales would expand the number of gas stations selling gasoline blended with higher amounts of ethanol."

What's the problem with using E15 during the summer? Short answer it produces more pollution. As car hobbyists we

should be against expanding the usage of E15 gasoline. E15 is damaging to all air-cooled engines and water-cooled engines which are not made to run on it. E15 costs less at the pump but produces less power and lower mileage. E15 is not labeled well at the pump either. I've had to look carefully to make sure I am getting the right gasoline. I've seen pumps with regular, mid-grade, premium, E15, E85 and diesel. E15 usually has one octane point higher rating than E10 and it usually costs a little less. I've seen E10 and E15 both labeled as regular. We really don't need more sales of E15 and we certainly don't want E15 to replace E10 leaving our older engines with no fuel.

From SEMA again: "SEMA opposes this proposed rulemaking and the expansion of the sale of E15. The EPA has turned to sales of E15 to achieve the Renewable Fuel Standard's artificial mandates to blend large volumes of ethanol into gasoline sold in the United States. Ethanol, especially in higher concentrations such as E15, can cause damage to high-performance parts and vehicles manufactured prior to 2001." The comment period ended on April 22<sup>nd</sup>.

I think what will happen is the EPA will rush this new rule and allow the selling of E15 year round. This is another step toward poor quality gasoline that doesn't perform as well as all gas gasoline while decreasing mileage and risking engine damage. This is pure politics and not doing what would be practical, or what a lot of people want – just plain gasoline that performs well while being safe for your engine.
