- Richmond Raceway Track Laps for Charity: Sunday, March 22nd Event hosted by Richmond Raceway. Take your vehicle for a spin around Richmond Raceway! Experience what it's like to take the banks of America's Premier Short Track. For just \$20, you can take five laps around the historic 3/4-mile D-shaped oval. While you are here, take a tour of the FanGrounds to see the unique views from in the infield, turn a few laps in the Richmond Raceway iRacing Simulator, play some cornhole. Track Laps proceeds will benefit Richmond Raceway Cares, a donor advised fund of The NASCAR Foundation, a 501(c)3 charitable entity, that donates racing-related items and offers financial support to assist community outreach programs and other nonprofit charities. The proceeds from this event will benefit Bair Foundation. Fans will enter at the main gate at the corner of Laburnum Ave. and Richmond-Henrico Turnpike. We accept cash, check and all major credit cards.

Join Apex Track events for a track day experience at NCCar located in Garysburg, NC (about 1.5 hrs from Richmond). This road course is ideally situated in Garysburg, NC and features a 40 feet wide bi-directional freshly paved road course with a ½ mile straightaway, 11 constant radius turns and large grassy run-off areas. There is no competition for times or trophies but a lot of fun to be had. Virtually any car is fully capable of handling this type of event. ## March 2020 Car Hobbyist News From The Council

This car hobbyist news needs a disclaimer. The General Assembly is still in session as this is being written which means that almost anything listed here can change. Even if a bill passes both houses the governor can veto it or simply send it back for revision. Also bills that have passed one house and are in the other house can still be killed or amended. If a bill passes one house and gets amended in the other house it cannot go to the governor for signature until both houses pass the exact same version. If the houses pass two different versions then a conference committee composed of three members of each house hammers out a bill that will go to both houses for approval. To see the exact status of each transportation related bill (status is in red) go to <http://vaacc.org/legis1.html> - bill status will be updated regularly. With all that said let's see what looks like it will become law and what will not.

The two bills I highlighted of interest to car hobbyists have both failed. The bill to force drivers to burn headlights 24/7 has thankfully been killed. This is the second time I can recall a bill like this being introduced into the Assembly. Virginia would have been the only state to require this nonsense. The bill to allow aftermarket exhaust for all vehicles with rules set by the State Police has been killed. I don't like bills that dump "make it work" on a government agency. The State Police would have had to come up with some way of measuring exhaust noise. This would be expensive and time consuming. The bills to end state inspections have been killed. The governor's only reason for this is that most states have gotten rid of inspections. I do not recall anyone else calling for the end of inspections. It does look like we will have a reduction in vehicle registration fees

for daily drivers. There is a bill to add \$4 to the registration for funding the State Police.

It looks like a bill to allow people who are not citizens to get a driver license will pass. It also looks like some type of ban on using a cell phone will also pass. And we will most definitely get some amount of gasoline tax increase statewide. Here in central Virginia it looks like at least 7.6 cents per gallon increase as a regional tax and 4 cents additional statewide tax. It does look like the speed for reckless driving will be changed from exceeding 80 to exceeding 85. An increase in towing fees looks like it will become law. The amount of vehicle liability insurance coverage limits may be increased. It appears we may have laws that require all passengers in a vehicle to wear safety belts and will allow localities to lower the speed limit below 25, but not less than 15, miles per hour in business and residential districts.

The ICEing bill was killed. ICE – internal combustion engine – bill would have provided a \$500 civil fine for blocking electric charging stations with vehicles that do not use them. It has become popular for drivers of large diesel trucks to block electric vehicles from the charging stations. I guess this is sort of a protest of the government trying to force people into replacing fossil fuel vehicles with electric “coal” vehicles. There is a bill in the Assembly to give up to a \$4500 tax credit for the purchase of a new electric vehicle. The federal tax rebate program for electrics is going to be phased out in the future.

The good news!!! No bill for the Transportation and Climate Initiative ever got introduced. The TCI program would have increased gas taxes by 10 to 17 cents per gallon – as a start – with the increase going to about a dollar. That money would have been used to try to get us to buy electric vehicles and other projects that would not have made a difference in greenhouse gases. The TCI's main goal is to reduce climate change but in reality, it would simply increase taxes. It also has a goal of having all electric vehicles by 2032 and rationing gas and diesel. This would have ended the car hobby as we know it. Because several people made this public a bill never got introduced. Also the Regional Greenhouse Gas Initiative bill was killed. This would have increased the price of electricity while doing next to nothing to reduce greenhouse gases.

The goal for next year is to make sure a TCI program does not get introduced and if it does to kill it. TCI reminds me of why the car club councils were started. In the 1990s there were so called Clunker Bills in several states including Virginia. These bills allowed gross air polluters like power plants to buy credits so they could continue to pollute. To get these credits old vehicles, many of which hadn't ran for years, were purchased, crushed and then the gross polluters were allowed to continue polluting. Crushing a non-running vehicle doesn't do anything for air pollution. It was a scam and we got it repealed in Virginia before it even began. TCI is the same – it's just a way to increase taxes while claiming to help end climate change when in reality it does very, very little to limit greenhouse gases.

Hopefully next month we should know exactly what bills are going to become law.
