Please review the changes below. They will be voted upon at the next meeting of the CVMC.

Article V— Officers Section 1

Change to: Elected officers of this club shall consist of president, 1st vice president, 2nd vice president, treasurer, secretary, and national director.

Add Section 5

President can appoint a person to a vacant office until an election can be held.

Article VI— Duties of Officers

Section 2. Duties of 1st vice president—

1) To assume the duties of the president in his/her absence and to attend all business and Board of Directors meetings.

2) To perform in such a capacity as directed by the president.

3) To serve as annual car show chairperson.

Duties of the 2nd vice president—

1) To attend all business and Board of Directors meetings.

2) To serve as chairperson of the membership committee.

Article VIII— Membership Section 3

Dues shall be paid upon entry into the club and annually at the rate of \$18 per member. All dues are payable and membership is for a calendar year.

MINUTES OF MAY 3, 1989

Monte Evans was handling refreshments and door prizes for this meeting. He advised he had the usual soft drinks for sale. The night's door prizes were tire covers and a Ford hat. He advised that the Mustang 25th Anniversary banner would be raffled off at a later date. Monte advised he was checking to see if any other banners were available. The club participated in "All Ford Day" at Engleside Plantation. This is an annual event and we always have good club participation. The club provided the food so there was a picnic at the end of the day.




