## PRESIDENT'S PERSPECTIVE MARCH/APRIL, 1989

A situation has arisen that requires me to issue a reminder. When ever a member is discussing the Club involvement, remember: the officers and the Board of Directors establish the terms and conditions of the involvement. We do appreciate the efforts of the membership but the ultimate responsibility falls on the Board of Directors. It is very difficult for us to correct a situation after the fact. So please, just state the Club is interested pending approval of the Board of Directors. Thank you.

With that out of the way, by now you all have received your official application to the Petersburg Ford show on April 22nd. As it now stands, we will only be required to judge the cars in the show, Petersburg Ford is doing everything else. At this point our compensation will be the remainder of the entrance fees after expenses. So it is in our best interest to get as many cars to the

show as is possible. The rumor has it that the Saleen racing cars and trucks will be present at the show. Petersburg Ford will have as many new performance cars as they can get (Mustang GT, Escort GT, Thunderbird SC, and Taurus SHO), two radio stations, and as much excitement as they can generate. So it should be fun.

Below are excerpts from a letter I wrote to Petersburg Ford regarding the upcoming show.

The advertising going to clubs and potential participants should note that the judging will be done with relaxed rules, as opposed to strict MCA rules. We have found that less than 8% of the people showing Mustangs prefer MCA rules. Strict rules keep many folks away.

We just had a Board of Directors meeting and the consensus of the Board is the Central Virginia Mustang Club will put forth every effort to make the

April 22nd show a success. However, we are extremely displeased that due consideration had not been given as to the compensation to the Club. I would like to suggest that in the event there are no remaining monies after the show, Petersburg Ford make a donation to the Club treasury in appreciation for the use of mailing labels, expertise, and judges. This would ensure continued cooperation in future events.

## MINUTES OF FEBRUARY 1, 1989

Minutes of Central Virginia Mustang Club held at Richmond Ford on Wednesday, February 1, 1989.

President, Terry Wagner called the meeting to order at 7:30 p.m.

Treasurer's report was given by Barbara Evans. The Club had a balance of \$1,493.13 in the treasury.

Carroll Lipscombe, Parade Chairman advised he was looking into the St. Patrick's Day parade.

Monte Evans, Speaker Chairman and NASCAR Chairman advised that Bill Jarvis would be the speaker. Monte updated the Club on the Winston Cup practice sessions at Daytona. He noted that Mark Martin was the fastest Ford in practice.

Mike Walker, Membership Chairman advised that 34 members had renewed.

Bonnie Fischer, Scrapbook Chairman said she would accept any information for the scrapbook.

Nellie Fischer, Merchandise Chairman advised that the sweatshirts were in. She advised she had T-shirts, polo shirts, mirrors and hats for sale.

Carolyn Timms, Newsletter Editor was not present but it was noted that all articles, etc. for the newsletter were greatly appreciated.

Kenny Fischer, Car Show Chairman announced the annual AACA Show at Richmond Fairgrounds April 29, 1989. He also reminded the Club that anyone interested in showing their car in the two upcoming mall shows should contact him as soon as possible to sign up. The shows in question are Eastgate Mall, May 12-13. This show will be advertised by the mall. Also a show is planned for Willow Lawn the weekend of June 12-15. Both shows represent income for the Club.

Judy Evans, Refreshments Chairman advised she had the usual drinks for sale. Door prizes were a Mustang mirror and a CVMC shirt (both donated by Kenny and Nellie Fischer).

Terry Wagner touched briefly on the upcoming CVMC show at Petersburg Ford on April 22. It was noted that details were not

final. The Club was advised that plenty of space was available, and that the vendors would have a large area. Tentatively, 20 classes were set up.

Bill Jarvis reported on his research into purchasing Club decals. He advised that 300 inside decals had been ordered and should be ready in about 2-3 weeks. The decals will have a white background with a blue horse and state with red lettering.

Terry Wagner also informed the Club that lightweight CVMC jackets were available. The price is \$38 and available in Black, Navy, Royal Blue and Gray. See Nellie Fischer if you wish to order. Also, it was noted that if any member wished the CVMC logo stitched on any clothing item, it was available for a \$6 fee. This is at your own risk. See Terry Wagner for all the details.

Kenny Fischer also bought up the regular CVMC car show planned for August. It was stressed that a new location had not been found. He urged all members to seriously think about a new location. Any suggestions, please contact Kenny.

## MINUTES OF MARCH 1, 1989

Minutes of Central Virginia Mustang Club held at Richmond Ford on Wednesday, March 1, 1989.

President, Terry Wagner called the meeting to order at 7:30 p.m.

Barbara Evans gave the Treasurer's report, the balance in the treasury was \$1,247.55. She handed out a statement for 1988 (see elsewhere in the newsletter).

Nellie Fischer was absent, but Kenny noted all the usual merchandise was available for sale.

Donna Seay, Picnic, Party Chairman advised that tentative plans were for a picnic in May.

Carroll Lipscombe advised that we were registered for the St. Patrick's Day parade March 19. All interested were advised to be at Reynold's Metals on Broad Street by 11:15 am.

Monte Evans, NASCAR and Speaker Chairman advised that Carroll Lipscombe would be the speaker.

Judy Evans, Refreshments Chairman advised that she had Octane Boost and a Mustang book for door prizes.

Mike Walker, Membership Chairman advised we had 40 current members. Mike advised that delinquent members would receive one more newsletter before they were dropped as members.

Kenny Fischer reminded the members of the AACA Show April 29 at Richmond Fairgrounds.

Kenny also reminded the Club of the April 22 Petersburg Ford Show, Eastgate Mall show May 12-13, and Willow Lawn show June 16, 17, 18. If you require additional information or wish to register, please contact Kenny ASAP.

Terry Wagner advised that the Club had received a letter from Campbell & Co., Ford's advertising company. This letter questioned our opinions on the 25th anniversary of the Mustang. It was noted that questionnaire would be answered by the Club.

Under old business, it was noted that the policy on the classified section of the newsletter had been set and is as follows:

Any Club member is allowed one classified ad (up to 5 lines) per newsletter free of charge. Ad must be in members name and not a business name. Ad must advertise specific items (such as 1 front bumper for sale). Not be general in nature (such as this month only 20% off all bumpers). Editor has final decision as to what ads are to be considered personal or business.

Any printing of ads or business cards is considered to be advertising and will be charged as so.

Any member wishing to place a free ad or any business who wishes to advertise should contact Carolyn Timms.

Bill Jarvis advised that decals were in. 300 decals cost the Club \$181.00.

A motion was made and passed that all members in good standing with membership paid in full would receive one decal free. Additional decals can be purchased from Mike Walker at \$1 each. If you have paid your 1989 dues you may contact Mike for your decal.

Bill Jarvis also asked the Club if anyone was interested in CVMC hat pins. Bill was advised to research the price, etc. of the pins. He will report back at the next meeting. Bill felt that pins would cost somewhere between \$2-\$3, but he was not sure.

Mike Timms bought up a question to the floor. He was concerned with the income expected this year; would CVMC be liable for a large amount of federal taxes for 1989. Barbara Evans, Treasurer advised that at this point the income was being spent as soon as it comes in, and that she felt that the tax burden will not be that much.

Terry Wagner updated the members on the April 22 Petersburg Ford CVMC car show. It was noted that Petersburg Ford did not guarantee any money for the Club for this show. The Club would be given a donation of what was left after expenses. It was discussed that Petersburg Ford was under the impression that the CVMC was planning to do this show for the fun of it, and for goodwill to the community. Even though there was miscommunication,

the Board of Directors had decided to proceed with the show since we were committed. Most felt even with the miscommunication that this would be good for the Club and could be an annual show.

It was bought up by Donna Seay, Secretary that no member had the authority to commit the Club to any show, judging, or activity without formally bringing it in front of the Board of Directors or Club membership. If such commitments were made in the future without the Board of Directors or membership's approval, they would not be honored. If any member has a lead or suggestion for a show, etc. they should contact an officer or board member. We still encourage members to investigate profitable or high visibility activities for the Club to participate, but we stress no commitment should be made without Club approval.

A discussion was held and it was decided to proceed with a CVMC booth at the AACA car show April 29. This booth would inform the public of the Club and recruit new members. Anyone interested should contact Kenny Fischer.

It was also noted that member, Mike Walker would have his Tri-W Race Team back in action April 2 for the first Enduro of the season at Southside Speedway.

It was also noted that the next meeting was April 5.

Meeting adjourned.

## 1988 FINANCIAL STATEMENT

Financially speaking, 1988 was a very good year. I'm not going to bore you with a lot of facts and figures because the 1988 Financial Statement is included in this issue of our newsletter. But I would like to point out a couple of things.

In 1987, our total income for the year was \$5,337 while in 1988 we raised \$7,621, roughly a \$2,300 increase. Most of the increased dollars came from the August car show and membership dues. A lot of people worked hard this past year to help fill our coffees and I would like to say "THANK YOU!"

Our expenses in 1987 were \$5,879 compared to \$7,309 in 1988, roughly a \$2,550 increase. Most of the increase came from the August car show.

In 1987 we spent \$542 more than we took in. In 1988 we took in \$312 more than we spent. Which means we are not deficit spenders. And that's not voodoo economics and that's the really good news.

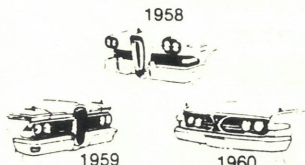

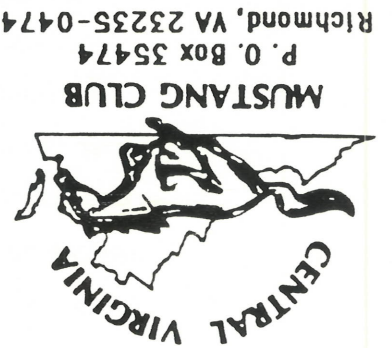
