

RICK'S TIPS

**REPRODUCTION HOOD
UPDATE**

There are many advantages of using a new hood versus trying to use the hood that came on the car originally. The old hood on the car usually has a ton of grease underneath, cracking or peeling paint, old damage or rust underneath, or all of the above. By the time all these problems are corrected, it is often cheaper to purchase a new hood than to try and make the old hood look like new again.

The old battle begins. Ford versus reproduction. Ford has just raised their prices again and the Ford hoods are over \$300.00. Reproduction hoods are still under \$200.00. However, the reproduction hoods do not fit at the firewall, the stampings are off. Another problem that will occur is on the underside of the reproduction hood. The repro hood skin is not welded to the repro hood frame. After the underside is painted, the repro hood and repro frame during opening and closing will move and separate causing the paint to break and crack around the seam (about 4 inches from the hood edge all the way around). The solution is to weld the frame to the frame hood around the edges about every 4 inches (Ford spot welds these). Then use body seam sealer to seal the two pieces. This is what Ford did originally to the hoods and will stop the paint from cracking.

In the absence of Monte Evans, President, the November meeting of the CVMC was called to order at Richmond Ford at 7:30 p.m. by Kenny Fischer, Vice-President.

Nellie Fischer announced she had some Club merchandise with her and when asked about ordering Club jackets, she reminded everyone that 6 is the minimum number for which we can place an order.

Kenny mentioned Bill's BBQ on southside, near Dick Strauss Ford as a better place for our Club cruise on Saturday night. Since members from a lot of the other car clubs have started going over there, quite a few cars usually gather in that parking lot.

Kevin Kean announced that we have reached the 100 paid member mark after much work this year and asked that all members please read his letter in the November newsletter and come to him with any suggestions or problems you may have regarding the Club.

A discussion regarding donations to charities at the end of the year followed and Mike Timms brought up the point that the Board of Directors felt it was a good idea to try to keep a bank balance of \$1,000.00. It was felt a working budget for next year was a good idea. Barbara Evans made a motion we wait until the next meeting to make a decision regarding the amount of our charitable contribution.

Proposed changes to the By-Laws which were in the November newsletter were voted on and

passed. A motion that Article XII, Amendment Section 2 be further changed deleting the wording "latest Robert's Rules of Order" and replacing it with the wording "existing By-Laws" also passed.

A proposal was made that another section be added to Article V, which would then read: Article V, Section 5. At the September meeting a nominating committee shall be appointed to draw up the slate of officers to be voted on. This committee shall not consist of any person currently holding an office. Absentee ballots will be mailed 2 weeks prior to the November meeting only to persons requesting them. A motion was made this proposal be considered at our next meeting.

Elections: For members who were voting at the meeting, signing the ballot was optional and Kevin would check the records to be sure voting was done by members in good standing only as the ballots were returned to him.

Break: There were many winning tickets during the raffle.

Kenny suggested members wishing to participate should bring a new toy for the Marine's Christmas "Toys for Tots" campaign to the next meeting.

Everyone is invited to go to Friendly's after the meeting.

Meeting adjourned.
