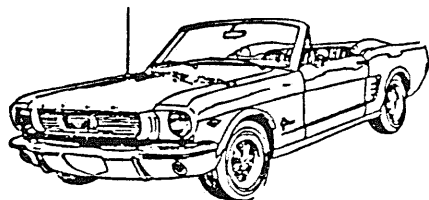

She also read a thank you note from Kevin Johnson for a \$100 donation from the club to his medical fund.

Nellie Fischer, merchandise chairman, advised she had crystal cars and pewter keychains for sale.

A special cruise was discussed. The club decided that a cruise would be held Sunday, March 11. Members are to meet at Eastgate Mall/Fairfield Commons in front of Sears at 1:30. The club will drive to Jamestown down Rt. 5 and take the ferry. Tentative plans include a dinner stop.

scheduled at the next meeting after research into other related events in the area during these two months had been done.
