

RICK'S TIPS

UNDERCARRIAGE DETAIL

This one is tough. Most car's underside fall into four categories. Those being; the underside is garaged and nice, undercoated, covered with oil or rusty scale. Most cars fall into all four.

The ideal way to clean the underside is to completely dismantle the car, build a car turner, and turn the car on its side and sandblast until only bare clean metal is showing. The equipment to do this will set you back the cost of a decent '65 convertible, so let us look at some alternatives.

If the car is a nice garaged original it is best to leave the underside alone. I would recommend spraying the underside with some type of preservative such as Armour All or an equivalent to keep the moisture off.

If your underside is covered with oil it has hopefully been protected from the elements and you might find a beautiful underside once the oil is removed. Any one of the engine degreasers will work along with kerosene and gasoline. Try not to scrap the heavy deposits with something sharp because this will remove

the protective coatings Ford used on the car. A hard bristle (no metal brush) should help. After degreasing spray, a light coating of protectant to keep rust from forming.

If you are fortunate to have a car that was undercoated from new you are probably in the best position to detail.

First, degrease the undercoating using cleaners previously mentioned (the section where the car's underside is coated with oil). You may need to scrub the undercoating as you clean, again use a brush (non-metal bristles). Once clean, use rubberized undercoating that can be purchased at most parts stores. Once undercoating has been applied, wait an hour or two and soak with Armour All or an equivalent to give a factory look.

If you have rusty scale under the car, it is simply better to sandblast, however, a drill and wire brush attachment will help to preserve the underside. It is dangerous to your eyes to use a drill and wire brush because the dust created and rust flakes can become imbedded in your

eyes. Use eye glass protectors to cover your eyes and also purchase some dust masks to keep from inhaling the dust.


To remove the rust in this manner will take several days. Once the rust is off, purchase a bottle of rust preventive liquid. Some of the different names are "One Step" and "Ospho". These rust stoppers will change the rust to a black oxide and help stop rust from forming again. Follow the directions for the rust stoppers because they are acids.

Once the rust is arrested with a chemical solution, paint with black followed by undercoating. The judges of most shows will not take off for the non factory undercoating.

1990 RECOMMENDED BY-LAWS REVISIONS

The following changes and/or additions to the Central Virginia Mustang Club's By-Laws have been recommended by the By-Laws Committee. These changes and/or additions will be voted on at the November 7, 1990 meeting.

ARTICLE V OFFICERS

Section I:

No two (2) members of an immediate family and/or household may simultaneously hold the offices of President or Treasurer.

ARTICLE VI DUTIES OF OFFICERS

Section III:

Duties of the Second Vice President shall include but not be limited to:

A. To perform in such a capacity as directed by the President.

B. To assume chairmanship of the membership committee.

C. To keep accurate records of the current membership.

D. To notify the Board of Directors of delinquent membership dues.

E. To keep an accurate and up-to-date listing of all members and their mailing addresses.

ARTICLE VII PROCEDURES

Section III:

In the event of the death or incapacitation of the President and First Vice President, the following succession to the Presidency shall be Second Vice President, Treasurer, and then the Secretary until a new President can be elected by the membership.

ARTICLE VIII MEMBERSHIP

Section III:

Dues shall be paid upon entry into the Club and then on January 1st of each year at the rate of \$18.00 per member (which includes voting spouse or 1 other member of the household age 16 and over decided by the paying member for the current membership year). Members more than sixty (60) days delinquent in their dues will be automatically dropped from membership in the Club.

ARTICLE XI VOTING

Section IV:

Voting shall be by active

members and their spouses or one (1) other member in the household age 16 or over in good standing.

ARTICLE XII AMENDMENTS

Section II:

Two-thirds (2/3) of the voting members present will be required to carry any amendment, providing amendment is in accordance with latest Robert's Rules of Order.

ARTICLE XIII COMMITTEES

Section II:

The following committees shall be appointed at the first regular business meeting or as indicated at the commencement of the newly elected officers:

- D. Publicity & Newsletter
- E. Sponsors
- F. Judging
- G. Awards & Trophies
- H. Refreshments
- I. Club Merchandise
- J. Scrapbook
