Well, that's all for now. Hope to see you at the next meeting.




On December 26th, our 5 year old grandson Brian was playing football with his dad and his older brother Bobby. Well, Bobby landed on Brian and broke his left leg up next to the hip. The doctors put him in a body cast that goes from just under his arms to his ankle on his left leg and to his knee on his right leg. They said he would have to stay in this until the end of March. We were told to find him a child's reclining wheelchair to use. A chair like this would cost \$290.00 a month with hospitalization and about \$150.00 a month without hospitalization. Of course, their hospitalization wouldn't pay for the chair so they started searching for one, without any luck.

I told Billy since Don Smith is in the hospital equipment business let's ask him who we should contact to find a chair at a good price. He didn't think we should do that, but I talked him into it and at the January meeting we asked Don who to call. He told us to try Durable Medical on Midlothian Turnpike that he would call them if he needed something like that. Well, to make a long story short enough for this newsletter, Don called his friend John Mendez at Durable Medical, they found a chair which fits and when our daughter-in-law picked it up they treated Brian like a king and told her there was "No Charge", because Don had worked out "A Deal".

The point I'm trying to make is that the people in this club will help each other, "You pat my back and I'll pat yours" so to speak, you just have to ask.

Thank you, Don. We owe you one !
