BY-LAWS TO CHANGE

- 1.) Article V, Section 2. The proposal would move the election from November to December, with officers to take office in January.
- 2.) Article V, Section 3. This proposal would change the term of officer for officers to two years.

These changes are to be voted on at the next meeting.

Meet the new Boss. Here's a bone for those who would rather spend that much on a muscle car. A couple of pavement-chewing Mustang models are now available through Ford dealers. The Mustang Motor-sport 427 Mustang coupe and convertible, and the 429 Boss Hemi Mustang offer impressive power while meeting 50-state emissions standards.

Both engines have all-aluminum blocks and patented intake manifolds

that increase air flow by routing it through the center of the hood and the middle of the manifold, rather than from the sides as in the stock Mustang. The 427 makes 534 hp at 5700 rpm, and 556 lb ft of torque at 4600 rpm, resulting in 0-60 times of 3.8 seconds and 11-second quarter-miles. The 429's heads are still being tweaked so exact figures aren't available, but Mustang Motorsports expects about 570 hp and 585 lb ft of torque. Both cars can

top 200 mph naturally aspirated; the 427 can be had with an intercooled supercharger. A Borg-Warner T-56 six-speed manual is standard.

Other standard features include a carbon fiber hood and lightweight seats, more instrumentation, including a 230-mph speedometer, Ford Cobra brakes, Griggs Racing GR-40 torque arm suspension and 17-inch wheels.

The 427 coupe starts at \$46,900, the 429 Boss coupe at \$69,900. ►

SALEEN/ALLEN "RRR" SPEEDLAB SET NEW TRACK RECORD

**Tim Allen Finishes Sixth In Professional Racing Debut at
the SCCA World Challenge Series**

ELKHART LAKE, WI -- (July 10, 1995) Former SCCA Racing champions Steve Saleen and Bob Bondurant broke the current track record while Tim Allen finished sixth in his first professional auto racing competition at the SCCA World Challenge Series at Road America on July 8, 1995.

During the World Challenge Qualifying Round, Saleen qualified on the pole with a new track record and a fastest lap time of 2:17.980, recording an average speed of 104.36 mph on the 4 mile course. Bondurant took second place with a lap time of 2:18.174 and 104.21 mph.

Behind the wheel of a high-performance Saleen Mustang SR, Allen recorded a fastest lap of 94 mph average. Allen started eleventh and steadily improved his position, finishing sixth in the Sports Class in a 53-car field.

Allen was pleased with his finish and when asked how he felt after his first professional race, Disney's *Home Improvement* star responded, "I'm going to Disneyland!" Allen added, "My main focus was to just follow my teammates and to stay on the track. I'm just happy I finished."

Saleen/Allen Set New Record
2-2-2-2

A fuel injector crack prevented Saleen from finishing the competition. After being hit by a competitor, Bondurant was unable to finish the race due to mechanical failure.

Saleen is confident that the team will continue to do well in future competitions. "Given the success of Tim Allen's first race and our ability to beat existing track records, I'm excited about our next racing opportunity," said Saleen. "As any Saleen Mustang owner knows -- their car can beat any Corvette or Porsche -- the race team is out to prove it on the track."

Bondurant, who along with Saleen, helped teach Allen the basic skills of auto racing at his highly acclaimed purpose-built driver training center near Phoenix, said, "Tim loves to drive and has a real competitive nature. I think this is the start of a successful racing career for Allen."

Phenomenal crowds gathered at the Saleen/Allen "RRR" Hospitality tent where Allen, Saleen and Bondurant graciously signed autographs throughout the day. "We're very happy with the support our team is receiving," added Saleen. "With the addition of Allen, it really helps bring more public support to the sport of racing."

Aptly named for Allen's trademark he-man grunting noise, "RRR" boasts a trio of 550 hp Saleen SR Mustangs which competed against the likes of Porsche, Lotus, BMW, Nissan and Chevrolet's Corvette and Camaro.

Bondurant (#65) and Saleen (#55) will make their next appearance on August 5 at the Player's Ltee. Grand Prix de Trois-Rivieres in Quebec, Canada and will be joined by Allen (#75) at the Grand Prix of Dallas on September 8-10.

CENTRAL VIRGINIA MUSTANG CLUB
SHOW MEETING
JULY 15, 1995

A meeting to discuss the up-coming car show was held in conjunction with the annual summer picnic/pool party held at the home of Don and Cindy Smith. The meeting was called to order at 4:12 pm by President Kenny Fischer. Basically the same group of members have signed up to perform duties pertaining to the car show. A couple of new members have expressed an interest, but have not yet signed up.

Last year, CVMC had no voice in the way the show was conducted. The Shockhoe Slip Merchant's Association handled many of the details. We will go back to the program concept this year, with vendors and advertisers featured in the program. Ads will be sold for the publication. Brenda Jones and Karen Lane have had several contacts for doorprizes already. If merchants in The Shoppes at Willow Lawn wish to advertise in the program booklet or set up vendor tables, they must go through Dori, the manager. Lite 98 radio has also been contacted about doing a remote broadcast from the shopping center that day.

Kenny has received some interest in conducting a 50/50 raffle. It certainly does well at the car and craft show held twice yearly in Gloucester. It would be good public relations even if the raffle is a benefit for some public service group, such as a rescue squad or fire department. Brenda will contact the West End Rescue Squad concerning their interest in the project. Possibly they could bring a squad car for display. The Tuckahoe Rescue Squad will be contacted as a second choice.

Sponsors are needed for the trophy classes. The cost is about \$60 for an entire class (1st, 2nd, & 3rd). The Best of Show Trophy is about \$45 and two are needed, one each for Best Ford and Best Mustang. Kenny will contact the trophy business he usually does business with concerning price comparisons between trophies and plaques. Dash plaques will be given to the first 100 entrants, featuring the car that received the Best in Show Mustang trophy the previous year. Kenny will also check into getting a plaque for Richmond Ford in appreciation of their allowing CVMC to use the conference room for our meetings for the past many years.

Debbie Shaver raised the complaint heard last year concerning the "official" shirts worn by anyone who worked the car show, with no separate designation for judges and workers. Perhaps new shirts need to be designed with separate designations. Don Lane suggested a large button to designate judges, or perhaps a judges hat. He will check with Inge Sportswear and Graphic Design (one of our sponsors) in Ashland concerning new club tee-shirts in multi-colors featuring something similar to Bill's BBQ surrounded by classic cars. Need to check with Bill's BBQ about permission, possibly money for advertisement.

George Cosier suggested posting a judge at the registration desk to help entrants select the proper class from the beginning. This would be in conjunction with the poster that is usually at the registration site. An attempt will be made to park the cars by class this year. This was not possible last year in Shockhoe Slip.

Kenny read the green judges sheet from the National Show in Rocky Mount held in May. More than three modifications would place a vehicle in the modified class. The judges are revising the judges sheet to allow 1-6 choices in each category.

There will be no power in the area we are using at Willow Lawn, so arrangements must be made concerning power. The suggestion was made to contact Cheek & Shockley or McGeorge concerning the use/rental of a recreational vehicle for the day for a central office, information site. Also, if the RV doesn't have a generator system, we will need to borrow/rent one for the calculators and public address system. The use of a public address system is against Henrico County ordinance, so we will make limited use of such a system. Kenny will check with Dori about the use of a conference room in the mall should that be necessary as a last resort.

The trade magazines have all been notified and the notices have been seen in many of them. We will put an ad in the Richmond Times-Dispatch. There was discussion as to putting the ad in the classifieds vs. paying more for a small ad in the Sports section. The general consensus was that it would be worth the money to have an ad where more people will see it -- in the Sports section.

Extra Billys welcomes us after the show for a family dinner.

CHAPTER 18.

VIRGINIA MOTOR VEHICLE SCRAPPAGE PROGRAM

Sec.

46.2-1801. Definitions.

46.2-1802. Virginia Motor Vehicle Scrappage Program Fund.

46.2-1803. Issuance of vouchers or trade-in allowance in return for scrappage of eligible vehicles.

Sec.

46.2-1804. Regulations.

46.2-1805. Air pollution credits in return for contributions to Fund.

§ 46.2-1801. Definitions. — As used in this chapter, unless the context requires a different meaning:

"*Eligible vehicle*" means a motor vehicle manufactured for the 1981 model year or any earlier model year that (i) is titled in Virginia, (ii) is registered and principally garaged in Virginia, (iii) is neither an abandoned motor vehicle nor inoperable abandoned motor vehicle as those terms are defined in § 46.2-1200, and (iv) meets such other qualifications as may be established by the Department of Environmental Quality.

"*Fund*" means the Virginia Motor Vehicle Scrappage Program Fund provided for in § 46.2-1802.

"*Motor vehicle dealer*" or "*dealer*" means a motor vehicle dealer licensed as such under Chapter 15 (§ 46.2-1500 et seq.) of this title.

"*Salvage dealer*" means a salvage dealer licensed as such under Chapter 16 (§ 46.2-1600 et seq.) of this title. (1993, cc. 885, 886.)

Editor's note. — Acts 1993, c. 885, which enacted this section and has no expiration provisions of c. 885 shall expire on July 1, 1996. However, since Acts 1993, c. 886 also

§ 46.2-1802. Virginia Motor Vehicle Scrappage Program Fund. — There is hereby established within the state treasury a special fund known as the Virginia Motor Vehicle Scrappage Program Fund. Proceeds of the Fund shall be used to meet the costs of the Virginia Motor Vehicle Scrappage Program as provided for in this chapter and for no other purpose. The Comptroller shall oversee the operation of the Fund and maintain an accurate record of all transactions involving the Fund.

The Fund shall consist of such moneys as are appropriated to it by the General Assembly and of all donations, gifts, bequests, grants, endowments, and other moneys given, bequeathed, granted, or otherwise made available to the Fund.

The Executive Director of the Department of Environmental Quality is authorized to apply for, receive, and accept from the United States government or any agency or instrumentality thereof and from any other source, public or private, any and all gifts, grants, allotments, bequests, or devices of any nature which, in his opinion, are suitable for the purposes of this chapter and shall deposit them in the Fund.

Any moneys remaining in the Fund at the end of a biennium shall remain in the Fund and shall not revert to the general fund. Interest earned on moneys received by the Fund shall remain in the Fund and be credited to it. (1993, cc. 885, 886.)

Editor's note. — Acts 1993, c. 885, which enacted this section, provides in cl. 3 that the provisions of c. 885 shall expire on July 1, 1996. However, since Acts 1993, c. 886 also

§ 46.2-1803. Issuance of vouchers or trade-in allowance in return for scrappage of eligible vehicles. — A. At the discretion of its owner, an eligible vehicle may be delivered for scrappage either (i) directly to a salvage dealer or (ii) to a motor vehicle dealer who, in turn, delivers such vehicles to a salvage dealer. If the vehicle is delivered to a salvage dealer, the salvage dealer shall, in exchange for the vehicle, present the vehicle owner with a voucher. If the vehicle is delivered to a motor vehicle dealer, the dealer shall, in exchange for the vehicle, at the options of the vehicle owner, either (i) present the vehicle owner with a voucher or (ii) retain the voucher in exchange for a trade-in allowance to be applied toward the purchase of a vehicle from the dealer. The Commissioner of the Department of Motor Vehicles shall supply all forms necessary to carry out the provisions of this subsection and may promulgate such regulations as he deems necessary or convenient to carry out the provisions of this subsection.

B. Each voucher shall have a value of \$700 payable to the bearer by the State Treasurer out of the proceeds of the Fund. Payments shall be made by check at the end of each calendar quarter. If, in any quarter, the amount of unpaid vouchers exceeds the moneys available in the Fund, the State Treasurer shall pay vouchers in the order of their presentation and to the extent of available Fund proceeds. In any quarter, vouchers remaining unpaid from a preceding quarter shall be paid, in the order presented, before payment of vouchers presented in the present quarter. Vouchers shall have no expiration date, but shall remain valid until paid. (1993, cc. 885, 886.)

Editor's note. — Acts 1993, cc. 885 and 886, cl. 2 provides: "That the voucher program provided for in this act shall become effective upon the certification by the Comptroller to the Commissioner of the Department of Motor Vehicles and the Executive Director of the Department of Air Pollution Control that the Virginia Motor Vehicle Scrappage Fund, pro-

vided for in this act, has attained a minimum balance of one million dollars."

Acts 1993, c. 885, which enacted this section, provides in cl. 3 that the provisions of c. 885 shall expire on July 1, 1996. However, since Acts 1993, c. 886 also enacted this section and has no expiration date, this section will continue to be in effect after July 1, 1996.

§ 46.2-1804. Regulations. — The Department of Motor Vehicles shall adopt regulations (i) providing for verification of vehicle eligibility for inclusion in the program provided for in this chapter and (ii) setting forth the responsibilities of motor vehicle dealers and salvage dealers under this chapter. The Comptroller by regulation shall specify the form and content of vouchers issued under this chapter. The Commissioner of the Department of Motor Vehicles, the Executive Director of the Department of Environmental Quality, and the Comptroller may, within the scope of their respective duties, powers, and responsibilities under this chapter, promulgate regulations necessary or convenient to carry out the provisions of this chapter. (1993, cc. 885, 886.)

Editor's note. — Acts 1993, c. 885, which enacted this section, provides in cl. 3 that the provisions of c. 885 shall expire on July 1, 1996. However, since Acts 1993, c. 886 also

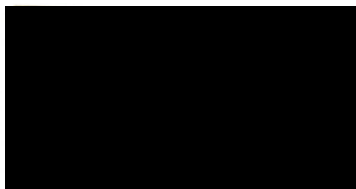
