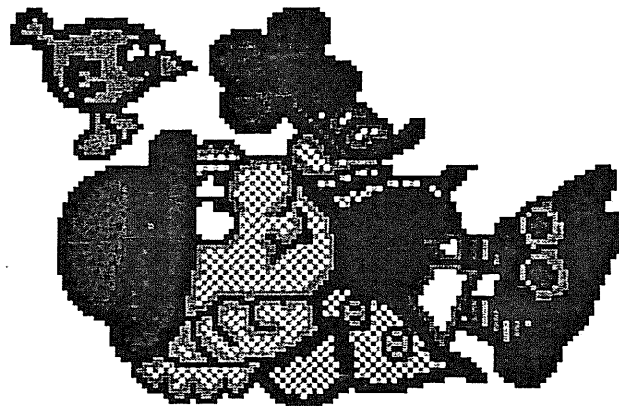

CENTRAL VIRGINIA MUSTANG CLUB  
FEBRUARY 2, 2000

President George Cosier called the February meeting of the Central Virginia Mustang Club to order at 7:31 PM. He wished everyone a good evening and welcome. There were no guests or visitors present, just us.

Second Vice-president Susan Morris reported that we have 44 paid members. Annual dues are \$18.00 and were officially due on January 1. She listed the February birthdays. Get well wishes are extended to Mustang Bill, Walter Harley, Bill Jarvis, Cindy Smith, and Carroll Lipscombe.

Treasurer Karen Lane reported a beginning balance of \$1732.74 plus \$486.00 (dues) plus \$75.00 (cash returned) minus \$39.10 (printing newsletter) minus \$24.10 (phone) minus \$90.00 (registrations for St Patrick's Day Parade) minus \$79.91 (food for Board of Director's meeting/ Show meeting) for a final balance of \$2060.63.

Editor Richard S reminded the members that he has established an earlier deadline than in the past for articles to be included in the newsletter. He would like to receive materials within 10 days of the general membership meeting. There were extra copies of the February newsletter available for anyone who did not yet receive theirs. He is going to try to include 3 pages of inserts in the next newsletter, but needs to check the postal department regulations regarding weight. There was no President's letter this month; George didn't have anything to say.

George reported on the latest edition of *SVT Enthusiast*. There will only be 300 units of the new model of the Cobra R and all will be Performance Red on the exterior. It will have an estimated 385 hp and will have a price tag of about \$70,000.

First Vice-president Mike Young asked all car show committee persons to continue working hard. His son, Dusty, received his learner's permit yesterday. Memories... Dusty has the '66 coupe formerly driven by the Lanes, and known as The Pumpkin, to learn to drive.

Kenny Fischer listed items from the Bulletin Board. A '68 convertible, 6-cylinder, paid \$9000, appraised for \$12,000, will sell for \$8000. A '66 coupe, 6-cylinder, automatic for \$1700. Kenny also listed upcoming car shows. These are listed in the calendar of events.

George reported that he had talked with Carroll today. He will have his last chemotherapy treatment this week. He will soon start radiation treatments. He will have to go for these treatments five days a week for five weeks, for a total of 25 treatments. The minister from the Gethsemane Church of Christ, Carroll's church, is coordinating volunteers to assist Carroll in getting to and from his appointments. Carroll's spirits are low these days, but he knows he can't give up. Please give him a call (329-5901).

George briefly discussed the combined Board of Directors and Show meeting held on January 23, in the snow. There was a tremendous show of support for George's decision regarding Tom Barnett's protest following the last car show and the subsequent letters and accusations. Herbert Hudson feels the Directors did a thorough investigation into the incident and found no improprieties.

Head Judge Steve Shaver explained a little about how he would like to see the judging for the car show done. He would like to have as assistant judge for each of the major divisions: 1<sup>st</sup> Generation (David Lythgoe), 2<sup>nd</sup> Generation (need a volunteer), 3<sup>rd</sup> Generation (George Bobruvsky), 4<sup>th</sup> Generation (Susan Morris), and Modified (Lonnie Tucker).

Lew Stakes reminded members of the upcoming St Patrick's Day Parade, scheduled for Sunday, March 19. The theme this year will be "Y2K". The Azalea Parade will be at the end of April, probably the 29<sup>th</sup>.

There are 6 cars registered for the club display for the Asphalt Angles show at the ShowPlace. They are: Richard Jones ('64 ½ convertible), Linda Cosier ('67 convertible), Mike Young (mock-Shelby), Nellie Fischer ('88 LX), Don Lane ('65 coupe), and Bob Overbey (with Susan's '67). Possibly we will have a President's Day display with a red, white, and blue theme.

National Director Paul Oliver had no report.

Technical questions: Susan has a problem with her new Mustang. It falls out of the reverse gear and she can't get it into 5<sup>th</sup> gear. It sounds like a transmission, synchronizer problem. Lonnie questioned if the transmission is a 4-speed, not a 5-speed. Bob wondered if Susan has actually tried to use the clutch.

Please don't visit him if you are feeling ill because he is still undergoing chemotherapy for his non-Hodgkins lymphoma and his immune system is depressed. In lieu of flowers, the family requested donations to the church the Lipscombes attend, Gethsemane Church of Christ.

Treasurer Karen Lane reported a beginning balance of \$2113.00 plus \$1200 (RIR ticket collections) + \$126 (dues) minus \$1700.26 (RIR tickets, phone bill, Post Office Box rental, and printing newsletters) for a final balance of \$1738.74.

Second Vice-president Susan Morris reminded members that annual dues are \$18 and are due tonight. We currently have 25 paid members. Susan listed the January birthdays.

National Director Paul Oliver has Mustang Club of America applications, information regarding State legislative proposals, and Specialty Marketing information.

Last year they specifically did not want Mustangs because they wanted only highly modified cars. February 18-20 will be the dates for the Asphalt Angels show at the Showplace. We are permitted to display up to 8 cars in the club display. The entry deadline is January 15. The closest MCA show is in Virginia Beach on May 12-14.

Richard "S", newsletter editor, reminded members that we need volunteers to chair committees. Nellie Fischer will call current sponsors and confirm that they still wish to be sponsors and will honor their discounts. For example, NAPA doesn't honor the discount.

Herbert Hudson listed door prizes and refreshments.

George discussed the car show planned for September. The car show is what keeps the club alive, fiscally, and allows us to give something back to the community through the Virginia Blood Services. # News from Ford Motor Company

DETROIT, Feb. 3, 2000 - Ford Motor Company is taking a step forward to reach its vision of being on the leading edge of technology and connect more closely with its customers. In support of this vision, the company is announcing that eligible employees worldwide will be provided a computer, printer and Internet usage at home for a nominal fee.

"This program keeps Ford Motor Company and our worldwide team at the leading edge of e-business technology and skills," Ford Chief Executive Officer and President Jac Nasser said. "We're committed to serving consumers better by understanding how they think and act. Having a computer and Internet access in the home will accelerate the development of these skills, provide information across our business and offer opportunities to streamline our processes."

The program will be launched in the United States in the second quarter and will be rolled out globally within 12 months. In the United States, the fee is set at \$5 a month.

"It is clear that individuals and companies that want to be successful in the 21st century will need to be leaders in using the Internet and related technology," Ford Chairman Bill Ford said. "That's what this program is all about." "E-business is an integral part of our strategy to become the world's leading consumer company of automotive products and services. Today's announcement enhances our ability to reach our vision and further demonstrates our commitment to this e-business strategy," Nasser added.

Additional e-business ventures Ford has recently announced include the formation of auto-xchange with Oracle Corporation and the strategic alliances with Microsoft CarPoint, TeleTech, Yahoo!, Bolt.com, iVillage.com and UPS Logistics Group.

Bill Ford, Jac Nasser and UAW President Stephen P. Yokich handed over the first computers to Mike Rawson, a health and safety representative of UAW Local 900 at the Wayne Stamping and Assembly Plant in Wayne, Mich., and Toary Taylor, a product analyst for the Mustang program in Dearborn, Mich.

"This program is a tribute to the collective bargaining process and to our solid relationship with Ford Motor Company," Yokich said. UAW Vice President Ron Gettelfinger added: "Helping our members stay on top of new technology has always been a UAW priority. That's why we're pleased to help all of our UAW-Ford members get on line."

The overall program will be coordinated by PeoplePC, Inc. of San Francisco. The computers and printers will be provided by Hewlett-Packard Company of Palo Alto, Calif. UUNET, an MCI WorldCom company based in Fairfax, Va., will provide the Internet service.

"PeoplePC's mission is to give as many people as possible the opportunity to reap the rewards of the digital age by making it simple to get connected," said Nick Grouf, chairman and CEO of PeoplePC. "We are thrilled that Ford Motor Company shares this vision and is committing to making it a reality. This confirms Ford's position as the role model for forward-thinking organizations across the globe."

"Today's announcement showcases how enlightened companies are empowering their employees by making technology accessible," said Carleton (Carly) S. Fiorina, president and chief executive officer of Hewlett-Packard Company. "HP is proud to play a role in providing the technologies that will make the Internet a useful and practical tool for Ford employees."

"The Internet has transformed the way businesses communicate with their employees and customers," said Mark Spagnolo, president and chief executive officer of UUNET. "This agreement with Ford builds on our commitment to deliver the highest performance Internet services to businesses around the world. We commend Ford for empowering its employees and for its innovation and leadership in business today."

Employees will access the Internet through a special portal that will allow them to customize their options, preferences and shortcuts. The portal will offer direct links to many Ford services and information, and it will be customized for different regions of the world.

The base computer will have a 500-Mhz Celeron chip, 64 MB of RAM, a 4.3GB hard disk for storage, a CD-ROM, software, a 15-inch monitor, speakers and a modem. The printer will be a color inkjet. Employees can upgrade to three more powerful computers at their expense and the monthly fee will cover incidental personal use.

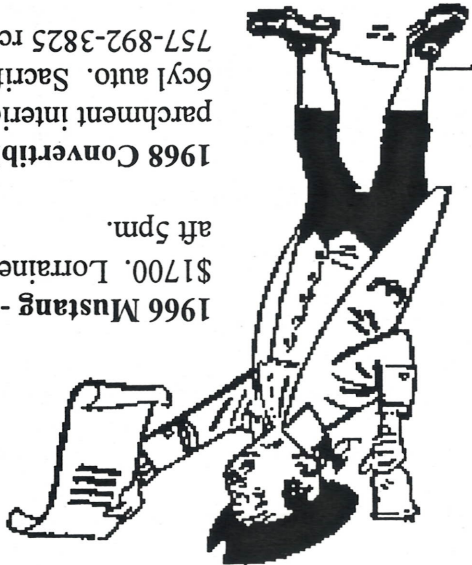
